The Supplementary Insurance is arranged and administered by Patent Plan Direct Limited an Appointed Representative of Beaumonts Insurance Brokers Ltd which is authorized and regulated by the Financial Services Authority, registration no. 306350. The insurance policy is underwritten by Hiscox Insurance Company Limited, 1 Great St Helen's, London EC3A 6HX (registered no.70234) which is authorized by the Financial Services Authority, FSA registration no. 113849. WHAT DOES THE POLICY COVER?

The Supplementary Insurance provides cover for costs incurred for temporary dental treatment as a result of a dental emergency when away from home or abroad, and cover towards the cost of permanent dental treatment following a dental injury. It also provides for the payment of out-of-hours fees when dentists are required to open their dental surgery to treat you in an emergency. There is also a hospital cash benefit payable when you are under the care of a dental or oral/maxillofacial surgeon and a cash benefit payable following the diagnosis of mouth cancer.

POLICY DURATION

The supplementary insurance is a monthly contract, which continues for as long as you continue to pay your monthly premiums.
